United States Air Force 1980 - July 1990, Stationed at various military installations worldwide.

Training Evaluator-Provided staff supervision in planning, developing, and implementing training evaluation projects, student measurement, student critique, and staff surveillance and self-inspection programs, Researched, developed, and implemented evaluation project's for 12 varied technical course curricula to ensure quality instruction and accurate information benefiting approximately 2000 trainees annually. Analyzed data gathered via filed visits, questionnaires, surveys, critiques, and inspection teams. January 1987- July 1990

Headquarters Squadron Section Commander Managed the Civil Engineering Squadron. Responsible for all personnel a related duty for over 400 subordinates including affirmative action and other employment laws. Directly, supervised, trained, evaluated, and assigned duties to eight subordinates. Maintained roads, facilities, and utilities for a 600 person military installation. Enforced standards and regulation to ensure discipline and productivity.

Special Assistant, Trusted with planning, coordinating, and monitoring administrative procedures and support for division personnel. Directly managed and supervised, division administrative personnel.

Administrative Assistant, Provided support in training and discipline in the overall operations of six enlisted student squadron and one officer student squadron. June 1985-October 1984.

Consolidated Aircraft Maintenance Squadron Section Commander

Established programs for personnel administration and management of 500 people. Provided required counseling, problem solving, decision-making, and to ensure squadron was managed properly. January 1984-December 1982.

Unit Executive Officer provided executive administrative support for 39()-munition maintenance; explosive disposal, supply, and weapons service section, immediately accountable for supervision, training, and rating of subordinate personnel. Ensured accuracy, quality, and compliance peer regulation and procedures. Maintained employment system data for the squadron and implemented directives. Job required being responsible for all personnel related duties and knowledge of employment of employment laws. December 1982-August 1980.
